The recent political upheaval brought about by the most recent "snap elections", Jaycee style anyway, is figuratively speaking a dark cloud hovering over the horizons of our "Twin Star" Jaycees future.

How come, and what really happened?

Our constitution provides that a Special General Assembly may be called by the LOM Board upon 15 days written notice to all affiliates. This provision was grossly and willfully violated by the 2006 Board when the Secretary-General called for an

It was more than a year ago when the then LOMPresident JCI Member Joan Salazar-Haresco created the Constitutional Commission (ConCom) to review and oversee whatever amendments in the LOM Constitution and By-laws would be necessary to suit with the provisions of the Junior Chamber International-Philippines (JCIP) charter which was ratified in the Boracay Constitutional Convention last October 8, 2005.

Duly appointed to comprise the LOM ConCom were Past NSEVP JC Sen. Hanorio P. Chu, Past President Ellie Acuesta, Jr., Past President Allan Licera, Past President Sandro Sagalongos, Past NVP Nestor Nolasco, Associate Member Carlito Ferrariz, and Immediate Past President Cecille Salangsang. This ConCom was likewise "directed to formulate the LOM Omnibus Election Code, and the LOM Policy Manual that would run parallel with the new proposed charter."

This move was considered very propitious, responsive, timely and rel-

evant taking into account that the previous years' elections (during the most recent Annual General Assemblies)were generally marred by unclear gripes of losing candidates, wayward interpretation of LOM CBL election provisions and election guidelines by a few, and long unresolved debates by some members due to the lack of appropriate LOM Policy Manual and the LOM Omnibus **Election Code** that would govern the conduct of an orderly, peaceful and fair elections. pursue the reforms already started by her predecessor. In a well-crafted inaugural speech, he enjoined every Jaycee to join him in his R.A.C.E.-a four pronged leadership agenda that would ultimately define his term.

R, of course, stood for reforms. And the centerpiece of which was the ratification of the CBL, and the approval of the corresponding LOM Policy Manual, and LOM Omnibus Election Code.

And indeed, the LOM CBL, LOM Policy Manual, LOM Omnibus Election Code, and even a LOM Membership Manual and Awards Manual were submitted, and consequently ratified by the



General Membership just a few months ago, as promised by our LOM President.

But alas, in one fell swoop, just after a few months of its ratification, the LOM CBL was trampled upon, ignored, debased, and almost relegated to the dustbin in a pseudo-election that was characterized by gross and willful violation of a number of election provisions as stipulated in the said LOM CBL and its accompanying Election Code.

Time, indeed, flies. And memories fail. Or maybe, some people tend to forget what the organization really stands for. And maybe, the Jaycee Creed does not anymore embody the ideals of every Jaycee. They are just recited in rote as mere preliminaries to Jaycee functions.

The past fifty-eight long Jaycee years of glorious leadership experience is no more? How can an "elected officer" swear to "abide by and uphold the constitution and by-laws of the LOM" which he has already willfully ignored, violated and debased?

The legitimacy issue must be resolved, lest we would be sending a wrong message to the succeeding Jaycee generations.

In January, during a meeting chaired by Hajslund, the 2006 JCI Executive Committee members pointed out that it was time to replace the slogan. They said "Entrepreneurs in Action," the previous slogan, had served the organization well but needed to be replaced by a new slogan for promotional and advertising purposes.

Agreeing that the new slogan needed to be current, reflect the organization as a whole, and have meaning in all JCI languages, they approved a motion to have a committee, comprised of members of the JCI Executive Committee and assisted by other staff, to work toward changing the slogan by the 2006 Congress.

Recommendation — June 2006

At their Midyear Meeting, JCI Executive Committee members considered a proposed new slogan, "Be Better," conceived by Marketing Director Louis Trahan. They compared it with successful slogans such as Nike's "Just Do It!" and decided that "Be Better" met the requirements for an effective slogan.

They pointed out that "Be Better" is short, concise and easy to remember, and will help JCl accomplish its mission. They also said that "Be Better" is specific enough to describe JCl's goals but broad enough to allow individual local and national organizations to operate according to their specific needs.

Additionally, they expressed that "Be Better" will accurately reflect the reality of what JCI members derive from being part of the organization.



Therefore, the JCI Executive Committee approved the motion to recommend "Be Better" as the proposed new JCI Corporate Slogan to replace "Entrepreneurs in Action."

Approval — September-October 2006

In September, the matter was submitted to the members of the JCI Board of Directors for approval by mail ballot. By a two-thirds (2/3) majority vote, the JCI Board of Directors officially approved the new JCI slogan "Be Better" in October.

Announcement — November 1006

During the JCI World Congress in November, Immediate Past President Cullinane presented the new Communications Strategy and the new corporate slogan.

"JCI will use the slogan, 'Be Better,' to communicate what the organization helps members achieve: to Be Better – better leaders, better managers, better professionals, better citizens, better business owners, better politicians, better parents, better spouses, better brothers, better sisters ...," said Cullinane..

One may presuppose that this slip up was intentionally done to evade apparent questions as to the legality, impropriety and validity of the so called "Election".

But all is not lost, at least at this point in time. We can still salvage the integrity of our LOM processes by allowing ourselves once and for all, to adhere to the electoral provisions of our CBL. We must also be reminded of the fourth tenet of our Jaycee Creed, "that government should be of laws, rather than of men."

A Jaycee leader should not only have integrity, but must always be responsible for his decisions and actions. Most importantly, he must have a moral ascendancy to govern.
